J2000: Up to 6 months. (Average expected outdoor life of product will depend on user definition of failure, climatic conditions, mounting techniques, and printed color).

#### **Chemical Resistance:**

Samples were printed using J50 series pigment inks with a BradyJet J5000 Color Label Printer by Brady recommended printer settings (Quality: Normal, Saturation: medium color + black). 100% Cyan(C), magenta(M), yellow(Y), and black (K) squares are printed for these tests.

Samples were printed using J20 series pigment inks with a BradyJet J2000 Color Label Printer by Brady recommended printer settings (Quality Mode: 3, Color Matching: best for graphics). 78% Cyan(C), magenta(M), yellow(Y), and process black (K) squares are printed for these tests.

Testing conducted at room temperature after equilibrating samples for 24 hours post printing.
